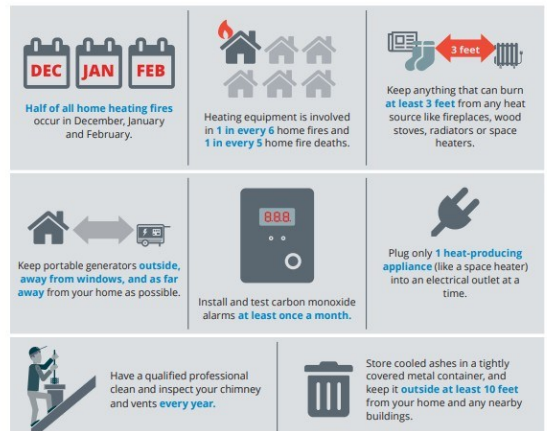

Brookville City Council Updates

- At the November 18 City Council meeting, Jared Ledford was sworn in as the city's newest City Council member. Jared completed the term left vacated with the resignation of James Zimmerlin earlier in the fall.
- At the December 2 Budget Workshop, Finance & HR Director Michelle Brandt presented the 2026 budget. Some highlights are below:
 - The city's total budget in 2026 will be \$21.4 million. 2025's total budget was \$14.7 million.
 - The city is projected to have a General Fund carry-over of approximately \$3.5 million from 2025. The General Fund carry over from the 2024 budget was approximately \$2.2 million.
 - The General Fund revenue is estimated to increase approximately \$1.7 million in 2026.
 - The city has budgeted approximately \$3.4 million for capital improvements and equipment purchases in 2026. \$2.1 million was budgeted for the same items in 2025.
 - The City will continue the street resurfacing program and Phase II of the Golden Gate Park parking lot resurfacing project in 2026.

- At the December 2 City Council Meeting, City Council approved the first reading of the updated Comprehensive Land Use Plan and scheduled the final public hearing for January 20, 2026 at 8:00 pm in the City Council Meeting Chambers.
- At the December 2 City Council Meeting, City Council approved the proposed subdivision plan for the BrookHaven Expansion, Phase I project.
- At the December 16 City Council meeting, City Council approved a new 3-year contract with Perry Twp. for fire and EMS services in the Brookville Fire District.
