Ordinance No. 2018-03 Passed February 20, 2018

AN ORDINANCE LEVYING SPECIAL ASSESSMENTS FOR THE CONSTRUCTION OF SIDEWALKS, CURBS AND GUTTERS IN THE CITY OF BROOKVILLE, OHIO.

WHEREAS, this Council did on the 2nd day of May 2017, duly adopt Resolution No. 17-23 declaring the necessity of constructing certain sidewalks, curbs and gutters for the Market Street Reconstruction Project; and

WHEREAS, the City of Brookville has subsequently constructed such sidewalks, curbs and gutters which were not constructed by the owners of the property abutting therein; and

WHEREAS, this Council did on the 17th of October 2017, duly adopt Ordinance No. 2017-11 levying special assessments for the construction of sidewalks, curbs and gutters for the Market Street Project; and

WHEREAS, no objections to said estimated assessments have been filed; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION I: The Council hereby approves and authorizes the Director of Finance to certify to the County Auditor the unpaid assessment for the Market Street Reconstruction Project being set forth in Exhibit A attached hereto and incorporated herein by reference.

SECTION II: The Director of Finance shall certify to the County Auditor the unpaid assessment within thirty (30) days after passage of this Ordinance.

SECTION III: This Ordinance shall take effect and be in force thirty (30) days after passage as provided by the Charter of the City of Brookville.
