Ordinance No. 2018-10 Passed July 17, 2018

AN ORDINANCE ADOPTING THE 2017 OHIO FIRE CODE FOR THE CITY OF BROOKVILLE, OHIO.

WHEREAS, the City of Brookville has previously adopted the 2011 Ohio Fire Code to provide fire code regulations for the City of Brookville; and

WHEREAS, the Ohio Department of Commerce, Division of State Fire Marshall has reviewed the Ohio Fire Code and adopted a revised version of the Ohio Fire Code known as the 2017 Ohio Fire Code; and

WHEREAS, the Council of the City of Brookville desires to adopt the revised 2017 Ohio Fire Code.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION I: The Council of the City of Brookville hereby adopts the 2017 Ohio Fire Code by amending Section 1501.01 of the Code of Ordinances as follows:

SECTION 1501.01 ADOPTION

The 2017 Ohio Fire Code (OFC), as adopted by the Ohio Department of Commerce, Division of State Fire Marshall, effective December 15, 2017, as published in Division 1301:7-7 of the Ohio Administrative Code (OAC), is hereby adopted by reference, as if fully rewritten herein.

SECTION II: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and all deliberations of this Council were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION III: This Ordinance shall take effect thirty (30) days after passage as provided by the Charter of the City of Brookville, Ohio.
