**AN ORDINANCE AMENDING THE CODE OF ORDINANCES PART 9, TITLE 3, SECTION 931.09 TAPPING PERMIT, SECTION 931.20(a), 931.20(b), 931.20(e)(2) FIXING THE RATES AND CHARGES AND 931.21(c) BILLING; SHUT-OFF FOR NONPAYMENT, RECONNECTION FEE TO ALL WATER CUSTOMERS IN THE CITY OF BROOKVILLE, OHIO.**

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO, THAT:**

**SECTION I:** Section 931.09 of the Code of Ordinances is hereby amended to read as follows:

In order to have water service installed in any premise, a tapping permit must be secured in the amount of one thousand five hundred dollars (\$1,500.00) at the City Manager's Office, setting forth the City lot and street number. Then a permit must be taken out and a service signed for at the office of the Dayton Division of Building Inspection of the Department of Service and Buildings by a duly licensed plumber.

**SECTION II:** Section 931.20(a) of the Code of Ordinances is hereby amended to read as follows:

There shall be a minimum charge for water, billed quarterly. The minimum charge is to cover investment, overhead expenses and the cost of being ready to serve with water. These minimum charges will be payable quarterly as due, at the following rates for the various sized meters.

## MINIMUM CHARGES PER QUARTER

5/8	inch meter	\$ 45.75
3/4	inch meter	\$ 55.80
1	inch meter	\$ 89.40
1½	inch meter	\$ 149.40
2	inch meter	\$ 249.90
3	inch meter	\$ 501.25
4	inch meter	\$ 775.50
6	inch meter	\$1,301.25

The following shall be additional charges per thousand cubic feet per quarter for the:

First 10,000 cubic feet	\$ 33.75
Next 90,000 cubic feet	\$ 32.00
Next 400,000 cubic feet	\$ 30.15
Next 500,000 cubic feet	\$ 24.65

These rates shall start and be in effect with the March 2018 billing for the water consumed during the previous quarter of December 2017 through February 2018.

**SECTION III:** Section 931.20(b) of the Code of Ordinances is hereby amended to read as follows:

There will be a penalty of ten percent (10%) of the total water bill added to the water charge if the bill is not paid within twenty-five days after the billing date on the water bill. If the water bill is not paid in full within forty-five days of the billing date on the water bill, the water service will be shut off. A shut-off notice will be mailed by regular mail to the property owner prior to the shut-off date. When it becomes necessary for the City to discontinue service to a customer for nonpayment of bills, service will be reinstated only after all bills for service then due have been paid, along with a turn-on charge. In the event that a consumer's water should be turned off due to nonpayment, there shall be a \$35.00 charge prior to the water service being restored.

**SECTION IV:** Section 931.20(e)(2) of the Code of Ordinances is hereby amended to read as follows:

Have a total household income that does not exceed thirty thousand dollars (\$30,000); and

**SECTION V:** Section 931.21(c) of the Code of Ordinances is hereby amended to read as follows:


In all cases where the water is turned off for any violation of the rules, the owner or occupant of such premises shall pay thirty-five dollars (\$35.00) prior to the water service being restored.

**SECTION VI:** This Ordinance shall revoke and rescind all Ordinances, and parts of Ordinances and Resolutions, and parts of Resolutions that are in conflict herewith.

**SECTION VII:** This Ordinance shall take effect thirty (30) days after passage as provided in the Charter of the City of Brookville.
