Ordinance No. 2017-17 Passed December 19, 2017

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES PART 9, TITLE 5, SECTION 957.06(a) FIXING THE RATES AND CHARGES, AND AMENDING SECTION 957.06(e)(2) TO ALL REFUSE CUSTOMERS SERVICED BY THE CITY OF BROOKVILLE, OHIO, AND TO REPEAL SECTION 957.03(c) AND SECTION 957.06(d).**

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO, THAT:**

**SECTION I:** Section 957.03(c) is hereby repealed.

**SECTION II:** Section 957.06(a) of the Code of Ordinances is hereby amended to read as follows:

(a) The following shall be the quarterly rates charged by the City of Brookville for trash and garbage collection and shall be based upon the number of collections per week and the amount of trash and garbage collected. The following rate schedule shall apply effective with the March 2018 billing for refuse collection for December 2017 through February 2018.

**CLASS I:** The minimum charge to be paid by each dwelling unit having not more than one cubic yard or less of garbage and trash per week and not more than one stop per week. Rate to be \$44.25 per quarter.

**CLASS II:** The minimum charge to be paid by each commercial (business, industrial, professional, etc.) place having not more than one cubic yard or less of garbage and trash per week and not more than one stop per week. Rate to be \$58.50 per quarter.

**SECTION III:** Section 957.06(d) is hereby repealed.

**SECTION IV:** Section 957.06(e) of the Code of Ordinances is hereby renumbered to 957.06(d) and amended to read as follows:

(d) There shall be a ten percent (10%) discount on the quarterly refuse billing for senior citizens or permanently and totally disabled citizens who apply for the discount and qualify for the discount. To receive the ten percent (10%) discount on the quarterly refuse billing, the refuse account customer shall meet the following qualifications:

- (1) Be 65 years old or older, or permanently and totally disabled, at the time of application; and
- (2) Have a total household income that does not exceed thirty thousand dollars (\$30,000); and
- (3) Own or rent your residence in the City of Brookville at the time of application for the discount, and reside in that residence.

An applicant for this ten percent (10%) senior citizen or permanently and totally disabled refuse discount shall be completed annually, and the applicant shall provide a copy of the current year tax return or other evidence of income deemed appropriate by the Finance Director to establish that the applicant qualifies for the discount. Upon approval of the application for the ten percent (10%) discount, the ten percent (10%) discount shall apply to the next quarterly billing after approval of the application. The ten percent (10%) discount shall continue for a period of one (1) year from the date of the application, and then the refuse consumer must reapply to continue to receive the ten percent (10%) discount.

**SECTION V:** This Ordinance shall revoke and rescind all Ordinances, parts of Ordinances, Resolutions, and parts of Resolutions that are in conflict herewith.


