Ordinance No. 2015-03

Passed SEPTEMBER 15TH, 2015

AN ORDINANCE ESTABLISHING A DEPARTMENT OF PUBLIC SERVICE AND A DIRECTOR OF PUBLIC SERVICE.

WHEREAS, Section 6.03 of the Charter of the City of Brookville permits the City Council to create new departments by ordinance or resolution and

WHEREAS, the Council of the City of Brookville has determined that it is necessary and proper to establish a Department of Public Service; and

WHEREAS, the Council of the City of Brookville desires to establish the position of Director of Public Service to manage the Department of Public Service

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION I: The Council of the City of Brookville hereby establishes the Department of Public Service.

SECTION II: The Council of the City of Brookville hereby establishes the position of Director of Public Service who shall manage the Department of Public Service.

SECTION III: The Council of the City of Brookville hereby adopts the following Chapter to be included within the Code of Ordinances for establishment and regulation of the Department of Public Service:

CHAPTER 141 DEPARTMENT OF PUBLIC SERVICE

141.01 DEPARTMENT OF PUBLIC SERVICE

(a) The Department of Public Service is hereby established in the City of Brookville.

(b) The Department of Public Service shall be managed and operated by a Director of Public Service who shall be selected by the City Council of the City of Brookville.

(c) The duties of the Director of Public Service shall include management of the water distribution system, solid waste collection, including yard waste and recycling, street and sign maintenance, storm water and sanitary sewer infrastructure, fleet procurement and maintenance of city equipment, buildings and grounds. The Director shall supervise the employees of the department, and shall be responsible for the fiscal management of the department.


(d) The Director of Public Service shall report to and act under the direction of the City Manager, and all department rules and regulations shall be approved by the City Manager prior to implementation by the Director of Public Service.

SECTION IV: This Ordinance shall take effect thirty (30) days after passage by the Council of the City of Brookville as provided in the Charter of the City of Brookville.
