

RECORD OF ORDINANCES

Ordinance No. 2014-09Passed NOVEMBER 4TH, 20 14**AN ORDINANCE VACATING A PORTION OF AN ALLEY ADJACENT TO MCKINLEY STREET IN THE CITY OF BROOKVILLE, OHIO.**

WHEREAS, Council has determined, pursuant to Section 723.05 of the Ohio Revised Code, that there is good cause for vacating a portion of an alley adjacent to and north of McKinley Street as set forth and described in the plat attached hereto as Exhibit "B" and incorporated herein by reference; and

WHEREAS, Council has determined that vacation of the alley will not be detrimental to the general interest; and

WHEREAS, Council further finds that all of the property owners abutting the area to be vacated have consented to the vacation of the public right-of-way, and therefore, that notice to adjoining property owners is not required under Section 723.06 of the Ohio Revised Code.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:


SECTION I: A portion of an alley adjacent to and north of McKinley Street, as set forth and described in the plat attached hereto as Exhibit "B" and incorporated herein by reference, is hereby vacated.

SECTION II: A certified copy of this Ordinance and plat of this alley vacation shall be filed with the office of the Montgomery County Recorder, and a copy of the Ordinance shall be submitted to the office of the Montgomery County Auditor by the Clerk of Council.

SECTION III: This Ordinance shall take effect thirty (30) days after passage as provided in the Charter of the City of Brookville, Ohio.






