Ordinance No. 2014-12 Passed NOVEMBER 18TH, 20 14

## AN ORDINANCE ESTABLISHING REGULATIONS PROHIBITING PLACING SNOW OR DEBRIS ON PUBLIC STREETS IN THE CITY OF BROOKVILLE, AND DECLARING IT AN EMERGENCY.

WHEREAS, the removal of snow and other debris from the public streets in the City of Brookville is necessary for public safety; and

WHEREAS, the Council of the City of Brookville has determined that it is necessary and proper to adopt this ordinance prohibiting the placing of snow or debris on public streets in the City of Brookville.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:**

**SECTION I:** The Council of the City of Brookville hereby adopts the following regulations prohibiting placing snow and other debris on public streets in the City of Brookville:


### 521.11 PLACING SNOW OR DEBRIS ON PUBLIC STREETS AND OTHER PUBLIC RIGHTS OF WAY

- (a) No person shall transfer snow from private property to any public street or public right-of-way.
- (b) No person shall place grass clippings or any other form of debris on the street or alley, except as may be allowed by City regulations or directive as to pick up of such materials by the City.
- (c) Whoever violates this section is guilty of a minor misdemeanor.

**SECTION II:** This Ordinance is declared to be an emergency measure for the immediate preservation of the public peace, health, safety, or welfare for the reason that immediate passage of this Ordinance shall permit it to be in effect for the upcoming winter season in which salt supplies are expected to be limited. Therefore, the Ordinance shall take effect immediately upon passage by Council pursuant to the Charter of the City of Brookville.




