AN ORDINANCE ADOPTING THE PROCEDURES ESTABLISHED IN OHIO REVISED CODE SECTIONS 3929.86(C) AND 3929.86(D) FOR DEPOSIT OF FIRE INSURANCE PROCEEDS TO ASSIST WITH THE RECOVERY OF COSTS INCURRED BY THE CITY OF BROOKVILLE FOR REPAIRING, REMOVING, OR SECURING FIRE-DAMAGED BUILDINGS OR OTHER STRUCTURES IN THE CITY OF BROOKVILLE.

WHEREAS, Ohio Revised Code Section 3929.86 permits municipal corporations to adopt the procedures set forth in Ohio Revised Code Section 3929.86(C) and 3929.86(D) to require the deposit of fire insurance proceeds with the designated officer of the City for certain fire loss claims to assist with the recovery of costs that may be incurred by the City for repairing, removing, or securing fire-damaged buildings or other structures; and

WHEREAS, the Council of the City of Brookville has determined that it is necessary and proper to adopt this Ordinance to address costs the City may incur in the event it is required to remove, repair, or secure a building or other structure that has been damaged by fire.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION I: The Council of the City of Brookville hereby adopts the following Section 1525.03 of the Code of Ordinances of the City of Brookville:

1525.03 DEPOSIT OF PROCEEDS FROM FIRE INSURANCE POLICIES

(a) The procedures contained in Sections 3929.86(C) and 3929.86(D) of the Ohio Revised Code for the recovery of costs incurred by the City in repairing, removing, or securing fire damaged buildings or other structures are hereby adopted by reference and made a part of this Chapter of the Code of Ordinances of the City of Brookville.

(b) The City Manager is hereby appointed as the person to carry out the duties set forth in Section 3929.86(C) and 3929.86(D) of the Ohio Revised Code for the City of Brookville.

SECTION II: The Clerk of Council is hereby directed to submit a certified copy of this Ordinance to Superintendent of Insurance on the effective date of this Ordinance.

SECTION III: This Ordinance shall take effect thirty (30) days after passage of this Ordinance as provided by the Charter of the City of Brookville, Ohio.
