Ordinance No. 2013-07 Passed July 16, 2013

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CERTAIN INSTALLMENT NOTE AGREEMENT WITH BROOKVILLE NATIONAL BANK, AND DECLARING IT AN EMERGENCY.

WHEREAS, the Council of the City of Brookville, Ohio has determined that it is necessary and proper to purchase a certain Sludge Dewatering Screw Press for the sum of \$250,000 to address sludge removal from its Wastewater Treatment Plant; and

WHEREAS, the Council of the City of Brookville has determined that it is necessary and proper to finance a portion of the purchase price of the Sludge Dewatering Screw Press;

WHEREAS, the Council of the City of Brookville desires to authorize the City Manager to enter into a certain Installment Note Agreement with Brookville National Bank for the purpose of obtaining financing in the amount of \$80,000 to be applied to the purchase of the Sludge Dewatering Screw Press.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION I: The Council of the City of Brookville hereby authorizes the City Manager to enter into and execute a certain Installment Note Agreement with Brookville National Bank in the amount of \$80,000 for a term of two years with interest thereon at a rate not to exceed 2.85% per annum for the purpose of purchasing the Sludge Dewatering Screw Press.

SECTION II: The City Manager and Finance Director shall be authorized to execute all necessary documents to complete this transaction.


SECTION III: It is hereby found and determined that all formal actions of this Council concerning and relating to passage of this Ordinance were passed in an open meeting of this Council, and that all deliberations of this Council were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION IV: This Ordinance is hereby declared to be an emergency measure to preserve the peace, health, safety and general welfare of the citizens of the City of Brookville for the reason that it is necessary to complete the purchase of the aforementioned Sludge Dewatering Screw Press immediately, and therefore, this Ordinance shall take effect immediately upon passage by two-thirds of the members of Council of the City of Brookville, Ohio.
