**AN ORDINANCE AMENDING THE CODE OF ORDINANCES PART 9, TITLE 5, SECTION 957.06(a) AND 957.06(d) FIXING THE RATES AND CHARGES TO ALL REFUSE CUSTOMERS SERVICED BY THE CITY OF BROOKVILLE, OHIO.**

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO, THAT:**

**SECTION I:** Section 957.06(a) and Section 957.06(d) of the Code of Ordinances are hereby amended to read as follows:

- (a) The following shall be the quarterly rates charged by the City of Brookville for trash and garbage collection and shall be based upon the number of collections per week and the amount of trash and garbage collected. The following rate schedule shall apply effective with the September 2012 billing for refuse collection for June, July and August:

**CLASS I:** The minimum charge to be paid by each dwelling unit having not more than one cubic yard or less of garbage and trash per week and not more than one stop per week. Rate to be 37.50 per quarter.

**CLASS II:** The minimum charge to be paid by each commercial (business, industrial, professional, etc.) place having not more than one cubic yard or less of garbage and trash per week and not more than one stop per week. Rate to be \$51.00 per quarter.

**CLASS III:** 1 collection per week 2 cubic yards \$ 67.50

**CLASS IV:** 1 collection per week 3 cubic yards \$100.25


**CLASS V:** 1 collection per week 4 cubic yards \$133.00

- (d) A charge of one dollar and fifty cents (\$1.50) per car tire, seven dollars and fifty cents (\$7.50) per car tire with rim, five dollars (\$5.00) per truck tire and ten dollars (\$10.00) per truck tire with rim shall be charged when the City picks up any tire or tires at any location within the city limits. Section 957.06(d) will be in effect thirty days from date of passage.

**SECTION II:** This Ordinance shall revoke and rescind all Ordinances, parts of Ordinances, Resolutions, and parts of Resolutions that are in conflict herewith and shall be enforced from and after the earliest period allowed by law.
