

# RECORD OF ORDINANCES

Ordinance No. 2010-04 Passed March 16, 2010

AN ORDINANCE AMENDING THE CODE OF ORDINANCES PART 9, TITLE 3, SECTION 931.17(a), INSTALLATION FEE, SECTION 931.22(a), FIRE LINE SERVICE CHARGES, SECTION 931.23, CHARGES FOR REPAIRS, SECTION 931.24, METER TEST FEES, ADDING SECTION 931.17(c), REPEALING SECTION 931.25, RENUMBERING SECTION 931.26 IN THE CITY OF BROOKVILLE, OHIO, AND DECLARING IT AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO, THAT:

**SECTION I:** Section 931.17 shall be renamed INSTALLATION FEE; RESUMED SERVICE FEE.

**SECTION II:** Section 931.17(a) is hereby amended to read as follows:

With the application for a meter set, the sum indicated in the following table shall be paid:

<u>Size of Meter</u>	<u>Amount</u>	<u>Size of Meter</u>	<u>Amount</u>
5/8 inch	\$ 81.00	2 inches	\$250.00
3/4 inch	\$ 81.00	3 inches	\$510.00
1 inch	\$ 81.00	4 inches	\$510.00
1½ inches	\$250.00	6 inches	\$510.00

**SECTION III:** Section 931.17(c) is hereby added as follows:

A resumed service fee of \$35.00 shall be charged for a resumed service when water service is shut-off but the water meter was not removed. Customers must contact the Municipality to resume an existing service.

**SECTION IV:** Section 931.22(a) is hereby amended to read as follows:

Size of service:	2 inches	3 inches	4 inches	6 inches	8 inches	10 inches
Rate per quarter:	\$11.00	\$11.00	\$55.00	\$55.00	\$82.50	\$82.50

**SECTION V:** Section 931.23 shall be renamed CHARGES FOR DAMAGED, FROZEN, LOST METERS.

**SECTION VI:** Section 931.23 is hereby amended to read:

All charges for replacement of AMR transmitters and AMR meters that are damaged, frozen, or lost will be replaced on an actual cost basis and must be paid when the next bill comes due. All AMR transmitters and AMR meters over one inch will be replaced on an actual cost basis plus a meter set fee.

**SECTION VII:** Section 931.24 is hereby amended to read:

The Department of Water meters are accurate within two percent (2%), or within the allowable tolerances established in the current American Water Works Association (“AWWA”) Standards, whichever is more stringent. The Customer or user may request a meter test at any time. In order to protect the Department of Water against unreasonable demands for service, a testing fee charge of \$110.00 for a 5/8" to 1" meter, \$302.50 for a 1½" meter and \$577.50 for 3" or larger meter, shall be made if the test shows the meter to be registering properly. If the meter is inaccurate, the water bill for the previous billing cycle shall be adjusted to the allowable percent limit and no charge for the test shall be assessed.

**SECTION VIII:** Section 931.25 is hereby rescinded and shall be removed from the Codified Ordinances.

**SECTION IX:** Section 931.26 is hereby renumbered 931.25.

**SECTION X:** This Ordinance shall revoke and rescind all Ordinances, and parts of Ordinances and Resolutions, and parts of Resolutions that are in conflict herewith and shall be enforced from and after the earliest period allowed by law.

**SECTION XI:** This Ordinance is hereby declared to be an emergency measure to preserve the public peace, health, safety and welfare of the citizens of the City of Brookville, Ohio and for the reason that the City of Dayton implemented new miscellaneous fees to be properly incorporated in our fees. This Ordinance shall take effect immediately upon passage of this Ordinance as provided by the Charter of the City of Brookville, Ohio.


