Ordinance No. 2009-12 Passed AUGUST 18, 2009

AN ORDINANCE RENAMING PAYLESS WAY TO COLLECTIVE WAY IN THE CITY OF BROOKVILLE, OHIO, AND DECLARING IT AN EMERGENCY.

WHEREAS, in the record plan for NORTHBROOK INDUSTRIAL PARK, SECTION FOUR, as recorded in Plat Book 207, Page 1-1A, of the plat records of Montgomery County, Ohio, a public street known as Brookville Drive was established; and

WHEREAS, in Ordinance No. 2007-13, the Council of the City of Brookville changed the name of Brookville Drive to Payless Way to honor the construction of a 600,000 sq. ft. distribution center by Payless ShoeSource, Inc. adjacent to said street; and

WHEREAS, a certified copy of Ordinance No. 2007-13 changing the name of Brookville Drive to Payless Way was recorded at ZRES-07-050767 of the records of the Montgomery County Recorder; and

WHEREAS, the distribution center is now being operated by Collective Brands, Inc. and the distribution center is being expanded to provide distribution for Stride-Rite products as well as Payless products; and

WHEREAS, Collective Brands, Inc. has requested that the street name of Payless Way be changed to Collective Way to avoid confusion for Stride-Rite customers ordering from the e-commerce site for Collective Brands; and

WHEREAS, Council desires to recognize and honor the commitment of Collective Brands, Inc. to the City of Brookville, Ohio by changing the name of Payless Way to Collective Way; and

WHEREAS, North American Nutrition Company, located at 10 Payless Way, consents to and supports the change of the street name to Collective Way; and

WHEREAS, Council has determined that there is good cause for changing the street name of Payless Way to Collective Way.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION I: The street name of Payless Way, as set forth and described in Exhibit A attached hereto and incorporated herein by reference, is hereby changed to Collective Way.


SECTION II: A certified copy of this Ordinance shall be filed with the office of the Montgomery County Recorder, and a copy of this Ordinance shall be submitted to the office of the Montgomery County Auditor by the Law Director of the City of Brookville, Ohio.

SECTION III: This Ordinance is hereby declared to be an emergency measure to preserve the public peace, health, safety and welfare of the citizens of the City of Brookville, Ohio to authorize the immediate renaming of this street and thereby permit the City of Brookville to proceed with immediately notifying all appropriate government and private agencies of this change of street name. This Ordinance shall take effect immediately upon passage of this Ordinance as provided by the Charter of the City of Brookville, Ohio.
