

RECORD OF ORDINANCES

Ordinance No. 2008-06Passed OCTOBER 21, 2008

AN ORDINANCE REZONING PART OF LOT 2173 OF THE REVISED AND CONSECUTIVE NUMBERS OF LOTS OF THE CITY OF BROOKVILLE, OHIO FROM ITS PRESENT CLASSIFICATION OF "I-2" GENERAL INDUSTRIAL DISTRICT, TO THE NEW CLASSIFICATION OF "HS" HIGHWAY SERVICE DISTRICT.

WHEREAS, an application has been filed for rezoning of a certain property located in the City of Brookville, being part of Lot 2173 and further described in "Exhibit A" attached hereto and incorporated herein by reference; and

WHEREAS, after the Public Hearing on the application, and upon written recommendation of the Planning Commission, Council by this Ordinance hereby approves said zoning amendment.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION I:



The zoning classification of certain property located in the City of Brookville, being part of Lot 2173, as further described in "Exhibit A" attached hereto and incorporated herein by reference, is hereby amended from its present zoning classification of "I-2" General Industrial District to the new classification of "HS" Highway Service District, pursuant to the zoning ordinances of the City of Brookville, Ohio.

SECTION II:

This Ordinance shall take effect thirty (30) days after passage by the Council of the City of Brookville as provided in the Charter of the City of Brookville.
