AN ORDINANCE LEVYING AN ASSESSMENT FOR THE INSTALLATION OF A REPLACEMENT WATER LINE AND A METER PIT ASSEMBLY ON THE SALEM STREET, PHASE III PROJECT IN THE CITY OF BROOKVILLE, OHIO, AND DECLARING IT AN EMERGENCY.

WHEREAS, pursuant to Section 931.21(g) of the Code of Ordinances of the City of Brookville, Ohio, the City may assess the cost of charges levied pursuant to Chapter 931 of the Code of Ordinances that is served by a connection to the water system of the Municipality; and

WHEREAS, the assessment remains unpaid more than thirty (30) days after the notice of assessment was sent to the owner by the Clerk of Council; and

WHEREAS, under Section 931.21(g), the Clerk of Council may certify unpaid assessments to the County Auditor to be placed on the tax duplicate and collected as other taxes are collected.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION I:

The Council hereby approves and authorizes the Clerk of Council to certify to the County Auditor the unpaid assessment for the installation of a replacement water line and a meter pit assembly during the Salem Street, Phase III Project, said assessment being set forth in Exhibit A attached hereto and incorporated herein by reference.

SECTION II:

The Clerk of Council shall certify to the County Auditor the unpaid assessment within thirty (30) days after passage of this Ordinance.

SECTION III:

This Ordinance is hereby declared to be an emergency measure to preserve the public peace, health, safety and welfare of the citizens of the City of Brookville, Ohio to permit the timely certification of the unpaid assessment to the County Auditor for collection during the next tax year. This Ordinance shall take effect immediately upon passage of this Ordinance as provided by the Charter of the City of Brookville.


