AN ORDINANCE REZONING LOTS 2176, 2177 AND PART OF LOT 2173 OF THE REVISED AND CONSECUTIVE NUMBERS OF LOTS OF THE CITY OF BROOKVILLE, OHIO, FROM ITS PRESENT CLASSIFICATION OF "I-2" GENERAL INDUSTRIAL DISTRICT, TO THE NEW CLASSIFICATION OF "HS" HIGHWAY SERVICE DISTRICT.

WHEREAS, an application has been filed for rezoning of a certain property located in the City of Brookville, being Lots 2176, 2177 and part of Lot 2173, and further described in Exhibit "A" attached hereto and incorporated herein by reference; and

WHEREAS, after the Public Hearing on the application, and upon written recommendation of the Planning Commission, Council by this Ordinance hereby approves said zoning amendment.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION I:

The zoning classification of certain property located in the City of Brookville, being Lots 2176, 2177 and part of Lot 2173, as further described in Exhibit "A" attached hereto and incorporated herein by reference, is hereby amended from its present zoning classification of "I-2" General Industrial District to the new classification of "HS" Highway Service District, pursuant to the zoning ordinances of the City of Brookville, Ohio.


SECTION II:

This Ordinance shall take effect thirty (30) days after passage by the Council of the City of Brookville as provided in the Charter of the City of Brookville.


