AN ORDINANCE PROHIBITING RESIDING IN OR OCCUPYING MOBILE HOMES, MOTOR HOMES, RECREATIONAL VEHICLES AND TRAILERS WHILE PARKED ON PUBLIC STREETS IN THE CITY OF BROOKVILLE, OHIO.

WHEREAS, the Council of the City of Brookville has received complaints from citizens in the City of Brookville regarding persons residing in or occupying mobile homes, motor homes, recreational vehicles, and trailers while parked on public streets of the City of Brookville; and

WHEREAS, the Council of the City of Brookville has determined that it is necessary to prohibit persons from residing in or occupying mobile homes, motor homes, recreational vehicles, and trailers while parked on public streets of the City of Brookville.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION I:

The Council hereby amends Section 351.06(c) to provide the following regulations:

Section 351.06(c) No person shall stop, park or leave standing any mobile home, motor home larger than one ton, attached recreational vehicle or trailer, or any attached trailer of any type, on any street, alley or municipal parking lot within the Municipality for a period longer than twenty-four hours, and no person shall reside in or occupy any of these vehicles while stopped, parked or standing on any street, alley or municipal parking lot within the Municipality.

SECTION II:


This Ordinance shall repeal or rescind any Ordinances or Resolutions in conflict herewith.


SECTION III:

This Ordinance shall take effect thirty (30) days after passage of this Ordinance as provided by the Charter of the City of Brookville.
