AN ORDINANCE AMENDING THE CODE OF ORDINANCES PART 9, TITLE 3, SECTION 931.20 (a) AND (b), FIXING THE RATES AND CHARGES TO ALL WATER CUSTOMERS; ADDING SECTION 931.21 (e), (f) AND (g), FIXING THE BILLING; SHUT-OFF FOR NONPAYMENT; RECONNECTION CHARGES AND RESCINDING SECTION 931.22 (e) AND (f) IN THE CITY OF BROOKVILLE, OHIO.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO, THAT;

SECTION I: Section 931.20 (a) of the Code of Ordinances is hereby amended to read as follows:

There shall be a minimum charge for water, billed quarterly. The minimum charge is to cover investment, overhead expenses and the cost of being ready to serve with water. These minimum charges will be payable quarterly as due, at the following rates for the various sized meters.

MINIMUM CHARGES PER QUARTER

5/8	inch meter	\$ 34.00
3/4	inch meter	\$ 41.50
1	inch meter	\$ 66.50
1½	inch meter	\$111.00
2	inch meter	\$185.50
3	inch meter	\$372.00
4	inch meter	\$561.00
6	inch meter	\$967.00

The following shall be additional charges per thousand cubic feet per quarter for the:

First	10,000 cubic feet	\$ 25.50
Next	90,000 cubic feet	\$ 24.25
Next	400,000 cubic feet	\$ 23.00
Next	500,000 cubic feet	\$ 19.00

These rates shall start and be in effect with the June 2006 billing for the water consumed during the previous quarter of March 2006 through May 2006.

SECTION II: Section 931.20 (b) of the Code of Ordinances is hereby amended to read as follows:

There will be a penalty of ten percent (10%) of the total water bill added to the water charge if the bill is not paid within twenty-five days after the billing date on the water bill. If the water bill is not paid in full within forty-five days of the billing date on the water bill, the water service will be shut-off. A shut-off notice will be mailed by regular mail to the property owner prior to the shut-off date. When it becomes necessary for the City to discontinue service to a customer for nonpayment of bills, service will be reinstated only after all bills for service then due have been paid, along with the turn-on charge. In the event that a consumer's water should be turned off due to nonpayment, there shall be a twenty-five dollar (\$25.00) charge prior to the water service being restored during the hours of 8:00 a.m. and 4:00 p.m., or a fifty dollar (\$50.00) charge between the hours of 4:00 p.m. and 8:00 a.m. and any time on the weekend or a holiday.

SECTION III: Section 931.21 (e) of the Code of Ordinances is hereby added as follows:

The City Manager or authorized representative may grant an extension of time for payment in cases of indigence, poor relief, and similar conditions, after investigation.

SECTION IV: Section 931.21 (f) of the Code of Ordinances is hereby added as follows:

No partial payments on such service bill for water, sewer and refuse collection shall be accepted.

SECTION V: Section 931.21 (g) of the Code of Ordinances is hereby added as follows:


Each charge levied pursuant to this chapter is made a lien upon the corresponding lot, land or premises served by a connection to the water system of the Municipality, and upon becoming delinquent the water service may be shut off and the charges shall be certified to the County Auditor, who shall place such charges on the tax duplicate of the County, along with interest and penalties allowed by law. This charge, including interest and penalties, shall be collected as other taxes are collected.

SECTION VI: Section 931.22 (e) and (f) are hereby rescinded and shall be removed from the Codified Ordinances.

SECTION VII: This Ordinance shall revoke and rescind all Ordinances, and parts of Ordinances and Resolutions, and parts of Resolutions that are in conflict herewith and shall be enforced from and after the earliest period allowed by law.


