Ordinance No. 2006-03

Passed July 18, 2006

AN ORDINANCE AMENDING THE CODE OF ORDINANCES PART 9, TITLE 3 AND 5 BY ADDING SECTION 931.20 (e), SECTION 935.14 (j) AND SECTION 957.06 (e) TO ESTABLISH A SENIOR CITIZEN OR PERMANENTLY AND TOTALLY DISABLED DISCOUNT IN THE CITY OF BROOKVILLE, OHIO.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO, THAT;

SECTION I: Section 931.20 (e) of the Code of Ordinances is hereby added as follows:

There shall be a ten percent (10%) discount on the quarterly water billing for senior citizens or permanently and totally disabled citizens who apply for the discount and qualify for the discount. To receive the 10% discount on the quarterly water billing, the water account customer shall meet the following qualifications:

- (1) Be 65 years old or older, or permanently and totally disabled, at the time of application; and
- (2) Have a total household income that does not exceed the total household income limit of the real property homestead exemption for the year in which the application is filed; and
- (3) Own or rent your residence in the City of Brookville at the time of application for the discount, and reside in that residence.

An application for this ten percent (10%) senior citizen or permanently and totally disabled water discount shall be completed annually, and the applicant must provide verification that the applicant currently receives the Homestead Exemption credit, or shall provide a copy of the current year tax return or other evidence of income deemed appropriate by the Finance Director to establish that the applicant qualifies for this discount. Upon approval of the application for the 10% discount, the 10% discount shall apply to the next quarterly billing after approval of the application. The 10% discount shall continue for a period of one (1) year from the date of the application, and then the water consumer must reapply to continue to receive the 10% discount.

SECTION II: Section 935.14 (j) of the Code of Ordinances is hereby added as follows:

There shall be a ten percent (10%) discount on the quarterly sewer billing for senior citizens or permanently and totally disabled citizens who apply for the discount and qualify for the discount. To receive the 10% discount on the quarterly sewer billing, the sewer account customer shall meet the following qualifications:

- (1) Be 65 years old or older, or permanently and totally disabled, at the time of application; and
- (2) Have a total household income that does not exceed the total household income limit of the real property homestead exemption for the year in which the application is filed; and
- (3) Own or rent your residence in the City of Brookville at the time of application for the discount, and reside in that residence.

An application for this ten percent (10%) senior citizen or permanently and totally disabled sewer discount shall be completed annually, and the applicant must provide verification that the applicant currently receives the Homestead Exemption credit, or shall provide a copy of the current year tax return or other evidence of income deemed appropriate by the Finance Director to establish that the applicant qualifies for this discount. Upon approval of the application for the 10% discount, the 10% discount shall apply to the next quarterly billing after approval of the application. The 10% discount shall continue for a period of one (1) year from the date of the application, and then the sewer consumer must reapply to continue to receive the 10% discount.

SECTION III: Section 957.06 (e) of the Code of Ordinances is hereby added as follows:


There shall be a ten percent (10%) discount on the quarterly refuse billing for senior citizens or permanently and totally disabled citizens who apply for the discount and qualify for the discount. To receive the 10% discount on the quarterly refuse billing, the refuse account customer shall meet the following qualifications:

- (1) Be 65 years old or older, or permanently and totally disabled, at the time of application; and
- (2) Have a total household income that does not exceed the total household income limit of the real property homestead exemption for the year in which the application is filed; and
- (3) Own or rent your residence in the City of Brookville at the time of application for the discount, and reside in that residence.

An application for this ten percent (10%) senior citizen or permanently and totally disabled refuse discount shall be completed annually, and the applicant must provide verification that the applicant currently receives the Homestead Exemption credit, or shall provide a copy of the current year tax return or other evidence of income deemed appropriate by the Finance Director to establish that the applicant qualifies for this discount. Upon approval of the application for the 10% discount, the 10% discount shall apply to the next quarterly billing after approval of the application. The 10% discount shall continue for a period of one (1) year from the date of the application, and then the refuse consumer must reapply to continue to receive the 10% discount.

SECTION IV: This Ordinance shall revoke and rescind all Ordinances, and parts of Ordinances and Resolutions, and parts of Resolutions that are in conflict herewith and shall be enforced from and after the earliest period allowed by law.
