Passed February 15th, 2005

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES PART 9, TITLE 5, SECTION 957.06 (a), FIXING THE RATES AND CHARGES TO ALL REFUSE CUSTOMERS SERVICED BY THE CITY OF BROOKVILLE, OHIO.**

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO, THAT;

**SECTION I:** Section 957.06 (a) of the Code of Ordinances is hereby amended to read as follows:

(a) The following shall be the quarterly rates charged by the City of Brookville for trash and garbage collection and shall be based upon the number of collections per week and the amount of trash and garbage collected. The following rate schedule shall apply effective with the April 2005 billing for refuse collection for December, January and February:

**CLASS I:** The minimum charge to be paid by each dwelling unit having not more than one cubic yard or less of garbage and trash per week and not more than one stop per week. Rate to be \$33.75 per quarter.

**CLASS II:** The minimum charge to be paid by each commercial (business, industrial, professional etc.) place having not more than one cubic yard or less of garbage and trash per week and not more than one stop per week. Rate to be \$45.75 per quarter.


**CLASS III:** 1 collection per week 2 cubic yards \$ 61.00

**CLASS IV:** 1 collection per week 3 cubic yards \$ 91.50

**CLASS V:** 1 collection per week 4 cubic yards \$122.00

**SECTION II:** This Ordinance shall revoke and rescind all Ordinances, parts of Ordinances and Resolutions and parts of Resolutions that are in conflict herewith and shall be enforced from and after the earliest period allowed by law.


