AN ORDINANCE CHANGING THE NAME OF BROOKVILLE-PYRMONT ROAD TO WESTERN AVENUE IN THE CITY OF BROOKVILLE, OHIO.

WHEREAS, Brookville-Pyrmont Road within the City of Brookville extends from its intersection with Westbrook Road to its intersection with Johnsville-Brookville Pike; and

WHEREAS, as a result of the opening of the new Brookville School facility and the creation of Blue Pride Drive, the City of Brookville plans to close a portion of Brookville-Pyrmont Road to traffic to provide safe and efficient ingress and egress to the new school; and

WHEREAS, the Council of the City of Brookville has determined that as a result of the changes to Brookville-Pyrmont Road within the City of Brookville that it would be necessary and proper to change the name of that portion of Brookville-Pyrmont Road between Westbrook Road and Johnsville-Brookville Pike to Western Avenue.


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION 1: The name of Brookville-Pyrmont Road within the City of Brookville, extending from its intersection with Westbrook Road to its intersection with Johnsville-Brookville Pike, is hereby changed to Western Avenue. A map of Brookville-Pyrmont Road within the City of Brookville hereby changed to the name of Western Avenue is attached hereto as Exhibit A and incorporated herein by reference.

SECTION 2: This Ordinance shall take effect thirty (30) days after passage as provided by Section 4.07(B) of the Charter of the City of Brookville.




