AN ORDINANCE AMENDING THE CODE OF ORDINANCES PART 9, TITLE 3, SECTION 931.09, FIXING THE TAPPING PERMIT CHARGES, AMENDING SECTION 931.17 (a), FIXING THE INSTALLATION CHARGES, AMENDING SECTION 931.20 (a) AND (b), FIXING THE RATES AND CHARGES TO ALL WATER CUSTOMERS AND AMENDING SECTION 931.21 (c), FIXING THE BILLING; SHUT-OFF FOR NONPAYMENT; RECONNECTION CHARGES IN THE CITY OF BROOKVILLE, OHIO.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO, THAT;

SECTION I: Section 931.09 of the Code of Ordinances is hereby amended to read as follows:

In order to have water service installed in any premise, a tapping permit must be secured in the amount of seven hundred fifty dollars (\$750.00) at the City Manager's Office, setting forth the City lot and street number. Then a permit must be taken out and a service signed for at the office of the Dayton Division of Building Inspection of the Department of Service and Buildings by a duly licensed plumber.

SECTION II: Section 931.17 (a) of the Code of Ordinances is hereby amended to read as follows:

SECTION III: Section 931.20 (a) of the Code of Ordinances is hereby amended to read as follows:

There shall be a minimum charge for water, billed quarterly. The minimum charge is to cover investment, overhead expenses and the cost of being ready to serve with water. These minimum charges will be payable quarterly as due, at the following rates for the various sized meters.

MINIMUM CHARGES PER QUARTER

½ or 5/8 inch meters	\$ 28.50
3/4 inch meter	\$ 35.00
1 inch meter	\$ 52.50
1½ inch meter	\$ 84.50
2 inch meter	\$138.00
3 inch meter	\$295.50
4 inch meter	\$456.50
6 inch meter	\$802.50

The following shall be additional charges per thousand cubic feet per quarter for the:

First 10,000 cubic feet	\$ 20.50
Next 90,000 cubic feet	\$ 19.50
Next 400,000 cubic feet	\$ 18.50
Next 500,000 cubic feet	\$ 17.50

These rates shall start and be in effect with the September 2005 billing for the water consumed during the previous quarter of June 2005 through August 2005.

SECTION IV: Section 931.20 (b) of the Code of Ordinances is hereby amended to read as follows:

There will be a penalty of ten percent (10%) of the total water bill added to the water charge if the bill is not paid within twenty-five days after the billing date on the water bill. If the water bill is not paid in full within forty-five days of the billing date on the water bill, the water service will be shut-off. A shut-off notice will be mailed to the property owner prior to the shut-off date. In the event that a consumer's water should be turned off due to nonpayment, there shall be a twenty-five dollar (\$25.00) charge prior to the water service being restored during the hours of 8:00 a.m. and 4:00 p.m., or a fifty dollar (\$50.00) charge between the hours of 4:00 p.m. and 8:00 a.m. and any time on the weekend or a holiday.


SECTION V: Section 931.21 (c) of the Code of Ordinances is hereby amended to read as follows:

In all cases where the water is turned off for any violation of the rules or failure to pay charges, the owner or occupant of such premises shall pay twenty-five dollars (\$25.00) between the hours of 8:00 a.m. and 4:00 p.m., or a fifty dollar (\$50.00) charge between the hours of 4:00 p.m. and 8:00 a.m. prior to the water service being restored.

SECTION VI: This Ordinance shall revoke and rescind all Ordinances, and parts of Ordinances and Resolutions, and parts of Resolutions that are in conflict herewith and shall be enforced from and after the earliest period allowed by law.
