## AN ORDINANCE PROHIBITING , SKATEBOARDING, ROLLERBLADING, AND IN-LINE SKATING ON CERTAIN PUBLIC RIGHTS OF WAY IN THE CITY OF BROOKVILLE.

WHEREAS, skateboarding, rollerblading, and in-line skating in the Community Center District and adjacent streets of the City of Brookville creates a hazard to pedestrians entering and exiting businesses in the district, and to motorists driving and parking in the district; and

WHEREAS, the City of Brookville has established a skate park near the Community Center District that provides a site for skateboarding, rollerblading, and in-line skating; and

WHEREAS, Council deems it necessary to prohibit skateboarding, rollerblading, and in-line skating on the public grounds of the Community Center District and adjacent streets to promote the safety of the public entering and exiting businesses in the area.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:


SECTION I: Council hereby adopts the following provision regulating skateboarding, rollerblading, and in-line skating in the Community Center District and adjacent areas in the City of Brookville, to be designated Section 377.04 of the Code of Ordinances:

No person shall ride a skateboard, rollerblade or in-line skate on any sidewalk, street, alley or other public ground in the Community Center District and adjacent areas in the City of Brookville. For purposes of this section, the Community Center District shall be that area currently zoned as "Community Center District" pursuant to the Brookville Zoning Code, except that area known as the municipal bikeway. The Community Center District and areas adjacent to the Community Center District where skateboarding, rollerblading, and in-line skating on any sidewalk, street, alley or other public ground shall be prohibited are the following specified areas: Market Street from Wolf Creek Street to Jefferson Street; Hay Street from Wolf Creek Street to Jefferson Street; Main Street from Wolf Creek Street to Jefferson Street; Walnut Street, Mulberry Street, and Sycamore Street from Hay Avenue to Main Street, and all alleys, sidewalks, or other public grounds within this area. The map of the area where skateboarding, rollerblading, and in-line skating is prohibited is attached as Exhibit A. Skateboarding, rollerblading, and in-line skating shall be permitted on the municipal bikeway within these areas. Whoever violates this section shall be subject to the penalty specified in Section 377.99 of the Code of Ordinances.

SECTION II: This Ordinance shall take effect and be in full force thirty (30) days after passage by Council as provided in the Charter of the City of Brookville.




