AN ORDINANCE AMENDING SECTION 1305.01 OF THE BUILDING CODE OF THE CODIFIED ORDINANCES OF THE CITY OF BROOKVILLE, OHIO TO UPDATE THE RESIDENTIAL BUILDING CODE.

WHEREAS, the City of Brookville has previously adopted the (OBOA) One, Two and Three Family Dwelling Code of 1999 and its subsequent amendments; and

WHEREAS, the (OBOA) One, Two and Three Family Dwelling Code has been updated, revised and re-titled; and

WHEREAS, the new OBOA Residential Code of Ohio has specific Appendixes which are required to be adopted by the City of Brookville.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO THAT:

SECTION I: Section 1305.01 of the Building Code is hereby amended as follows:

1305.01 ADOPTION.

Pursuant to Section 4.12 of the Charter of the City of Brookville, there is hereby adopted by reference by and for the City of Brookville the 2004 OHIO RESIDENTIAL CODE OF OHIO FOR ONE, TWO, AND THREE FAMILY DWELLINGS including: Appendix E Manufactured Housing Used as Dwellings; Appendix G Swimming Pools, Spas and Hot Tubs; and Appendix J Existing Buildings and Structures, including the Brookville/Miami Valley Amendments, and all subsequent revisions.


SECTION II: This Ordinance shall repeal all Ordinances, parts of Ordinances, Resolutions, and parts of Resolutions in conflict therewith.

SECTION III: This Ordinance shall take effect thirty (30) days after passage of the Ordinance as provided by the Charter of the City of Brookville.




