**AN ORDINANCE AMENDING THE CODE OF ORDINANCES PART 9, TITLE 3, SECTION 931.09, FIXING THE TAPPING PERMIT CHARGES, AMENDING SECTION 931.20 (a), FIXING THE RATES AND CHARGES TO ALL WATER CUSTOMERS AND AMENDING SECTION 931.22 (a), FIXING THE FIRE LINE SERVICE CHARGES IN THE CITY OF BROOKVILLE, OHIO.**

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO, THAT;

SECTION I: Section 931.09 of the Code of Ordinances is hereby amended to read as follows:

In order to have water service installed in any premise, a tapping permit must be secured in the amount of five hundred dollars (\$500.00) at the City Manager's Office, setting forth the City lot and street number. Then a permit must be taken out and a service signed for at the office of the Dayton Division of Building Inspection of the Department of Service and Buildings by a duly licensed plumber. The tapping permit fee of five hundred dollars (\$500.00) will be in effect thirty (30) days from date of passage.

SECTION II: Section 931.20 (a) of the Code of Ordinances is hereby amended to read as follows:

There shall be a minimum charge for water, billed quarterly. The minimum charge is to cover investment, overhead expenses and the cost of being ready to serve with water. These minimum charges will be payable quarterly as due, at the following rates for the various sized meters.

## MINIMUM CHARGES PER QUARTER

½ or 5/8 inch meters	\$ 22.15
¾ inch meter	\$ 26.93
1 inch meter	\$ 40.53
1½ inch meter	\$ 65.51
2 inch meter	\$107.07
3 inch meter	\$229.59
4 inch meter	\$354.73
6 inch meter	\$623.41

The following shall be additional charges per thousand cubic feet per quarter for the:

First 10,000 cubic feet	\$ 17.00
Next 90,000 cubic feet	\$ 16.15
Next 400,000 cubic feet	\$ 15.36
Next 500,000 cubic feet	\$ 14.62

These rates shall start and be in effect with the April 2002 billing for the water consumed during the previous quarter of December 2001 through February 2002.

SECTION III: Section 931.22 (a) of the Code of Ordinances is hereby amended to read as follows:

The following charges shall be made for the fire line service in addition to a tapping permit fee as set forth in Section 931.09 of the Code of Ordinances:

Size of service:	2 inches	3 inches	4 inches	6 inches	8 inches	10 inches
Rate per quarter:	\$6.25	\$9.38	\$12.50	\$25.00	\$46.88	\$73.13
