Ordinance No. **2002-02**Passed **FEBRUARY 5**, 2002
YEAR

AN ORDINANCE AMENDING THE CODE OF ORDINANCES PART 9, TITLE 3, SECTION 935.14 (a) AND (c)(1), FIXING THE RATES AND CHARGES TO ALL SEWER CUSTOMERS, AND AMENDING SECTION 935.15 (a), FIXING THE TAP-IN FEES IN THE CITY OF BROOKVILLE, OHIO.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO, THAT;

SECTION I: Section 935.14 (a) and (c)(1) of the Code of Ordinances is hereby amended to read as follows:

(a) For the payment of the proper and reasonable expense of operation, repair, replacement, improvements, additions, betterments, extensions and the maintenance of the sanitary sewer system and for the payment of the sums required to pay the principal and interest of all loans and bonds as they become due; Council shall enact and may from time to time, but no less than annually, review expenditures and revenues, and amend a schedule of just and equitable charges for the use of and services rendered by the municipal sewer system and wastewater treatment plant; which schedule of rates and charges shall be based upon the metered amount of water supplied to the premises. Revised rates shall start and be in effect from the effective date of passage by Council. Each schedule shall be maintained on file in the office of the Clerk of the City of Brookville while it is in effect.

(c) The following shall be the quarterly rates charged by the City for services to be rendered by its sanitary sewage system to it and to its inhabitants and others, based on water consumption. The rate schedule shall apply effective with the April 2002 billing for sewer usage as follows on:

(1) Domestic strength wastewater.

(A) First: Minimum charge for 1,000 cubic feet or less per quarter: Nineteen dollars and twenty-five cents (19.25).

(B) Second: Charge for each 100 cubic feet or any part thereof, in excess of 1,000 cubic feet, but less than 10,000 cubic feet: One dollar and ninety-three cents (\$1.93).

(C) Third: Charge for each 100 cubic feet, or any part thereof in excess of 10,000 cubic feet: One dollar and forty-nine cents (\$1.49).

(D) Fourth: There will be a twenty-five percent (25%) additional fee for consumers living outside of the municipal corporation limits.

SECTION II: Section 935.15 (a) of the Code of Ordinances is hereby amended to read as follows:

Before any person connects to or discharges sewerage into the sanitary sewer system or extends the use of the sanitary sewer system on his premises to additional dwelling, commercial, manufacturing, or other units, he shall pay to the City of Brookville as the permit fee for connecting to and discharging sewage into the sanitary sewer system a fee in the amounts shown below.

(a) For all connections to the sanitary sewer system, the fee shall be in the amount for the respective uses shown below, but in no case less than five hundred dollars (\$500.00)

<u>Residential</u>	<u>Fee</u>
Single-family residence	\$500.00 per residence
Two-family residence	\$750.00 per double
Multi-family apartments	\$500.00 plus \$200.00 for each additional unit



Commercial, Industrial, Institutional, Schools, Government	\$500.00 plus \$.20 per sq. ft.

The tapping permit fee, per the above schedule, will be in effect thirty (30) days from date of passage.

SECTION III: This Ordinance shall revoke and rescind all Ordinances, and parts of Ordinances and Resolutions, and parts of Resolutions that are in conflict herewith and shall be enforced from and after the earliest period allowed by law.




