AN ORDINANCE AMENDING CHAPTER 1161 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE.

WHEREAS, the Council of the Municipality of Brookville, upon recommendation of the Planning Commission, desires to amend certain sections of Chapter 1161 of the Code of Ordinances regulating signs in the Municipality.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION 1: Section 1161.05 (c) Political Signs is hereby amended as follows:

Political signs or posters concerning candidates for elective office or public issues to be decided by public election shall be displayed not more than forty-five (45) days and are to be removed no later than seven (7) days after said election. Such signs shall not exceed six (6) square feet in "R" districts and sixteen (16) square feet in other districts, shall not exceed six (6) feet in height, shall not be illuminated and shall not create a safety or visibility hazard, nor be affixed to any public utility pole. No permit nor fee will be required for political signs.

SECTION 2: Section 1161.14 (b) (5) is hereby amended as follows:

(5) Identification signs within two thousand (2,000) feet from the centerline of an interstate highway system are subject to the following provisions:

- A. Must conform to Federal and State Highway Standards.
- B. Limited to one sign not to exceed two hundred (200) square feet in area per face per principal business use.
- C. Only permitted and special uses in areas zoned highway service and special uses in areas zoned I-2 that are permitted uses in highway service shall qualify for these provisions.
- D. Sign height may be increased to fifty (50) feet measured from the elevation of the freeway in which oriented, but may not exceed one hundred (100) feet in any case measured from the base of the sign.

SECTION 3: All other sections of Chapter 1161 not specified herein shall remain in full force and effect and are not amended by this Ordinance.

SECTION 4: This Ordinance shall revoke and rescind all ordinances, parts of ordinances, resolutions, and parts of resolutions in conflict herewith, and shall take effect upon passage as provided in the Charter of the Municipality of Brookville, Ohio.
