AN ORDINANCE REZONING LOT NUMBER 1207 OF THE REVISED AND CONSECUTIVE NUMBERS OF LOTS OF THE MUNICIPALITY OF BROOKVILLE, OHIO, FROM ITS PRESENT CLASSIFICATION OF "CB" TO THE NEW CLASSIFICATION OF "GB".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

The classification of Lot No. 1207, located at 715 Market Street is hereby changed and rezoned from its present classification of "CB" to the new classification of "GB", as per the Zoning Ordinance of the Municipality of Brookville, Ohio.



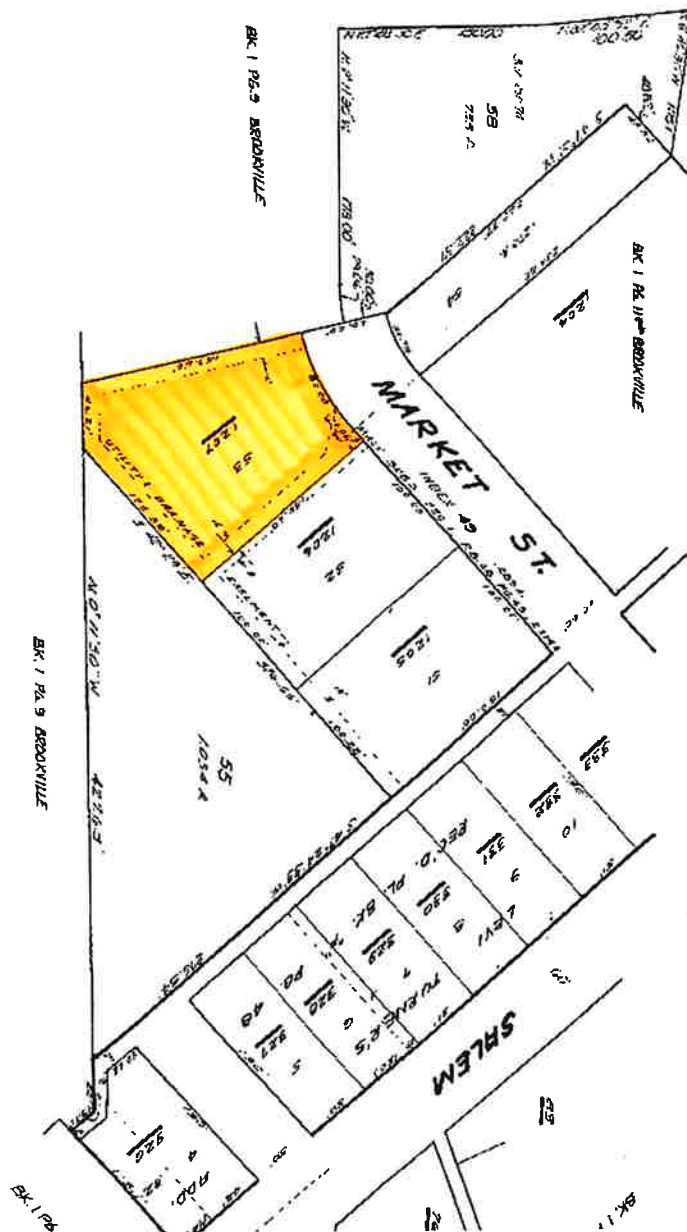
