AN ORDINANCE REZONING CERTAIN LOTS OF THE REVISED AND CONSECUTIVE NUMBERS OF LOTS OF THE MUNICIPALITY OF BROOKVILLE, OHIO, FROM ITS PRESENT CLASSIFICATION OF "HS" TO THE NEW CLASSIFICATION OF "R-3".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

The classification of part Lot #1495, containing approximately 3.3 total acres, located along the north side of Upper Lewisburg-Salem Road approximately 1300 feet north of Upper Lewisburg-Salem Road, from its present classification of "HS" to the new classification of "R-3", as per the Zoning Ordinance of the Municipality of Brookville, Ohio.

SECTION II:

This Ordinance shall revoke and rescind all Ordinances, parts of Ordinances; and all Resolutions and parts of Resolutions that are in conflict herewith and shall be enforced from and after the earlier period allowed by law.




