

**AN ORDINANCE REZONING CERTAIN LOTS OF THE REVISED AND CONSECUTIVE NUMBERS OF LOTS OF THE MUNICIPALITY OF BROOKVILLE, OHIO, FROM ITS PRESENT CLASSIFICATION OF "R-1B" TO THE NEW CLASSIFICATION OF "R-3".**

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

**SECTION I:**

The classification of part Lot #1710, containing approximately 1.7 total acres, located along the northwest side of Calmer Ernst Boulevard, from its present classification of "R-1B" to the new classification of "R-3", as per the Zoning Ordinance of the Municipality of Brookville, Ohio.


