

ORDINANCE NO. 1999-01

AN ORDINANCE TO ADOPT BY REFERENCE THE CONSTRUCTION STANDARDS AND DRAWINGS AND DESIGN CRITERIA PREPARED BY CHOICE ONE ENGINEERING, AND DECLARING AN EMERGENCY.

WHEREAS, the Municipality of Brookville is in need of having amended construction standards and drawings and design criteria for construction within the Municipality; and

WHEREAS, Choice One Engineering has prepared a suitable set of construction standards and drawings and design criteria for construction within the Municipality; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I: The construction standards and drawings and design criteria prepared by Choice One Engineering and now on file in the office of Clerk of this Municipality, are hereby adopted and approved by reference.

SECTION II: The Clerk of Council shall keep copies of the construction standards and drawings and design criteria prepared by Choice One Engineering hereby adopted by reference in the office of the Clerk to be available to interested persons.

SECTION III: The Clerk of Council shall not publish the entire construction standards and drawings and design criteria hereby adopted by reference, but shall only publish this Ordinance.

SECTION IV: All ordinances, Resolutions, and parts of Ordinances and Resolutions which are in conflict with any of the provisions of the aforementioned construction standards and drawings and design criteria hereby adopted by reference are repealed.

SECTION V: This Ordinance is declared to be an emergency measure to permit timely implementation of these standards prior to start of the construction season in 1999, and therefore, said Ordinance shall become effective immediately upon its passage by at least two-thirds of the members of Council pursuant to the Charter of the Municipality of Brookville, Ohio.
