AN ORDINANCE REZONING CERTAIN LOTS OF THE REVISED AND CONSECUTIVE NUMBERS OF LOTS OF THE MUNICIPALITY OF BROOKVILLE, OHIO, FROM ITS PRESENT CLASSIFICATION OF "R-2" TO THE NEW CLASSIFICATION OF "OR".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

The classification of Lot #1745, Lot #1746, and Lot #1747 containing approximately 6.49 total acres, located on the east side of Albert Road; from Salem Street to Upper Lewisburg-Salem Road is hereby changed and rezoned from its present classification of "R-2" to the new classification of "OR", as per the Zoning Ordinance of the Municipality of Brookville, Ohio.

SECTION II:

This Ordinance shall revoke and rescind all Ordinances, parts of Ordinances; and all Resolutions and parts of Resolutions that are in conflict herewith and shall be enforced from and after the earlier period allowed by law.
