

RECORD OF ORDINANCES

No. **1997-12** *Passed* December 16, **19** 97

AN ORDINANCE AMENDING THE CODE OF ORDINANCES, PART 9, TITLE 3, CHAPTER 931.20, PARAGRAPH A, AN ORDINANCE FIXING THE RATES AND CHARGES TO ALL WATER CONSUMERS AND CHAPTER 931.17, PARAGRAPHS A & B, FIXING THE INSTALLATION FEES IN THE MUNICIPALITY OF BROOKVILLE, OHIO.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I: WATER RATES

Chapter 931.20, Paragraph A is hereby amended to read as follows:

There shall be a minimum charge for water, billed quarterly. The minimum charge is to cover investment, overhead expense and the cost of being ready to serve with water. These minimum charges will be payable quarterly as due, at the following rates for the various sized meters.

MINIMUM CHARGES PER QUARTER

1/2 or 5/8 inch meters	\$21.50
3/4 inch meter	26.15
1 inch meter	39.35
1 1/2 inch meter	63.60
2 inch meter	103.95
3 inch meter	222.90
4 inch meter	344.40
6 inch meter	605.25

The following shall be additional charges per thousand cubic feet per quarter for the:

First 10,000 cubic feet	\$16.50
Next 90,000 cubic feet	15.68
Next 400,000 cubic feet	14.91
Over 500,000 cubic feet	14.19

These rates shall start and be in effect on the January 1998 billing for the water consumed during the previous quarter of September through November, 1997.

SECTION II METER INSTALLATION FEE:

Chapter 931.17, Paragraphs A & B are hereby amended as follows:

(a) With the application for a meter set, the sum indicated in the following table shall be paid:

5/8 inch	\$10.00	2 inch	\$44.00
3/4 inch	10.00	3 inch	88.00
1 inch	10.00	4 inch	99.00
1 1/2 inch	33.00	6 inch	154.00

(b) The above payment shall cover the cost of setting and delivering the meter.

SECTION III:

This Ordinance shall revoke and rescind all Ordinances, and parts of Ordinances, and Resolutions, and parts of Resolutions in conflict herewith.
