AN ORDINANCE ZONING CERTAIN LOTS OF THE REVISED CONSECUTIVE NUMBER OF LOTS OF THE MUNICIPALITY OF BROOKVILLE, OHIO, TO NEW CLASSIFICATIONS.

WHEREAS, the Municipality of Brookville, Ohio, recently annexed certain territory adjoining on the northeast side of the Village, on both sides of Salem Street from Albert Road east to the Corporation Limit, consisting of 84.706 acres to the Municipality of Brookville; and

WHEREAS, it has been deemed necessary and proper to provide zoning for this newly annexed territory.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO:

## SECTION I:

The classification of the real estate recently annexed to the Municipality of Brookville, Ohio is hereby zoned to the classification of R-1B on the northwest side of Salem Street; OR on the southeast side of Salem Street from Albert Road to Country Lane; and R-3 for the balance of the area, except for a small tract on the south side as I-2.

## SECTION II:

This Ordinance shall revoke and rescind all ordinances, parts of ordinances and resolutions that are in conflict herewith and shall be in force from and after the earliest period allowed by law.



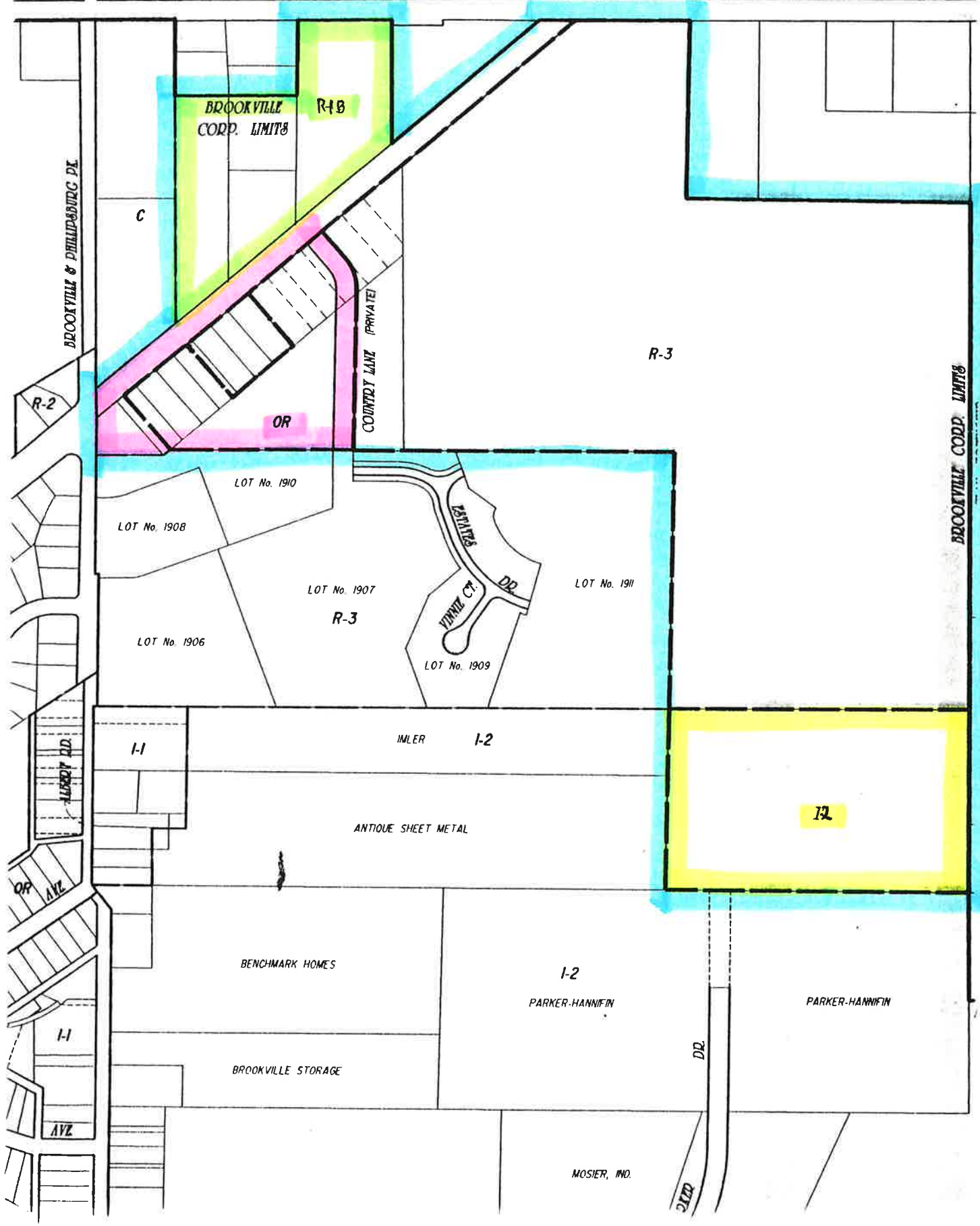
