AN ORDINANCE REPEALING AND RESCINDING CHAPTER 110 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO.

WHEREAS, Chapter 110 of the Code of Ordinances provides rules and regulations for the operation of commercial motor buses in the Municipality of Brookville; and

WHEREAS, the Council of the Municipality of Brookville has determined that the rules and regulations in Chapter 110 should be repealed and rescinded because the Municipality is not presently regulating any commercial motor bus operation and these rules and regulations contain provisions which maybe construed to be in conflict with current state and federal laws regulating commercial motor bus operations.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

## SECTION I:

Chapter 110 of the Code of Ordinances of the Municipality of Brookville, Ohio, consisting of Sections 110.01, 110.02, 110.03, 110.10, 110.11, 110.12, 110.13 and 110.99, is hereby repealed, revoked and rescinded, and shall have no further force and effect.

## SECTION II:

The Municipality of Brookville reserves the right to enact legislation to reinstate and adopt new rules and regulations for commercial motor bus operations in the future if Council deems said legislation to be necessary and appropriate at that time.

## SECTION III:

This Ordinance shall take effect upon its passage as provided by the Charter of the Municipality of Brookville, Ohio.




