## AN ORDINANCE REGULATING USE OF PATHS AND BIKEWAYS IN THE MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING IT AN EMERGENCY.

WHEREAS, Council deems it necessary to regulate the use of the bikeway and other paths set aside for the exclusive use of bicycle and pedestrian traffic in order to promote the safe use of said bikeways and paths in the Municipality of Brookville.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO:

### **SECTION I:**

No person shall operate a motor vehicle, snowmobile, all purpose vehicle or horse upon any path or bikeway set aside for the exclusive use of bicycles and pedestrian traffic, when an appropriate sign giving notice of such use is posted on the path or bikeway.

### **SECTION II:**

This Ordinance shall not prohibit public service vehicles, including but not limited to, service and maintenance vehicles and equipment, police, fire and emergency vehicles, from operating on said paths or bikeways in performance of official duties.

### **SECTION III:**

Whoever violates this Ordinance is guilty of a minor misdemeanor.

### **SECTION IV:**

This Ordinance shall revoke and rescind all Ordinances, parts of Ordinances, Resolutions, and parts of Resolutions that are in conflict herewith.



## SECTION V:


This Ordinance is declared to be an emergency measure to provide for the immediate regulation of the bikeway and thereby protecting the safety of those persons using the bikeway.


