AN ORDINANCE REZONING CERTAIN LOTS OF THE REVISED AND CONSECUTIVE NUMBERS OF LOTS OF THE MUNICIPALITY OF BROOKVILLE, OHIO FROM ITS PRESENT CLASSIFICATION OF C TO THE NEW CLASSIFICATION OF R-1A and R-1B.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

The classification of the following real estate, northwest corner of Arlington Road and Westbrook Road a.k.a. Kimmel property having frontage of approximately 1326 ft. along the north side of Westbrook Road, and approximately 1105 ft. along the west side of Arlington Road, consisting of approximately 41 acres, to be and the same is hereby changed and rezoned from its present classification of C to the classification of R-1A for approximately $16\frac{1}{2}$ acres 846 ft. by 884 ft. in the southwest corner of the tract with the balance of tract approximately $24\frac{1}{2}$ acres to be R-1B as per the Zoning Ordinance of the Municipality of Brookville, Ohio.





