Passed February 16, 1993

AN ORDINANCE CHANGING THE NAME OF BROOKVILLE-PHILLIPSBURG ROAD TO ALBERT ROAD, AND DECLARING IT AN EMERGENCY.

WHEREAS, the Council of the Municipality of Brookville did pass an Ordinance on October 6, 1992, No. 1992-14, accepting the Application for the Annexation of certain territory in Clay Township to the Municipality of Brookville; and

WHEREAS, a section of Brookville-Phillipsburg Road, between Brookville-Salem Road and Upper Lewisburg and Salem Road, was included in the territory annexed into the Municipality of Brookville; and

WHEREAS, it is deemed to be necessary to change the name of that section of Brookville-Phillipsburg Road that was annexed into the Municipality of Brookville to the name of Albert Road to provide for a single uniform name for this road through the Municipality of Brookville, and thereby avoid any confusion or mistake that may arise from the same road in the Municipality having two names; and

WHEREAS, this Ordinance is for the immediate preservation of the public health, safety and welfare of the citizens of Brookville, Ohio and, therefore, this measure shall be declared an emergency Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

Section I:

The name of that section of Brookville-Phillipsburg Road that commences at the intersection of Albert Road and Brookville-Salem Road and continues up to the south side of the intersection of Brookville-Phillipsburg Road and Upper Lewisburg-Salem Road is hereby changed and shall be hereafter known as Albert Road.

Section II:

This Ordinance is hereby declared to be an emergency ordinance for the immediate preservation of the public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio, and this Ordinance shall take effect and be in full force and effect from and after
