AN ORDINANCE AMENDING THE CODE OF ORDINANCES TITLE 5, SECTION 52.10 - AN ORDINANCE FIXING THE RATES AND CHARGES TO ALL REFUSE CUSTOMERS SERVICED BY THE MUNICIPALITY OF BROOKVILLE, OHIO.

WHEREAS, it is necessary to adjust the billing of refuse charges so they conform with the billing for water and sewer charges, and thereby make administration of the new computer billing system more efficient and cost effective; and

WHEREAS, it is necessary to bill for refuse collection in March, April, and May, 1993 to off-set the \$5.00 a ton tipping fee established in January 1993 by Montgomery County, as well as maintaining the normal operations of the Municipal Refuse Collection Services and to assist in the upgrading of the billing system for these services.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

Section I:

The rates charged by the Municipality of Brookville for trash and garbage collection shall be based upon the number of collections per week and the amount of trash and garbage collected. The following rate schedule shall apply effective on the July, 1993 billing for refuse collection for the period of March, April and May:

CLASS I: The minimum charge to be paid by each dwelling until having not more than one cubic yard or less of garbage and trash per week and not more than one stop per week. Rate to be \$30.00 per quarter.

CLASS II: The minimum charge to be paid by each commercial (business; industrial; professional; etc.) place having not more than one cubic yard or less of garbage and trash per week and not more than one stop per week. Rate to be \$40.50 per quarter.

CLASS III: 1 collection per week 2 cubic yards \$54.00

CLASS IV: 1 collection per week 3 cubic yards \$81.00

CLASS V: 1 collection per week 4 cubic yards \$108.00

Any additional pick-ups or yardage over and above a customers certain classification will be charged at actual costs as determined by the Municipal Manager.

There will be a penalty of ten percent (10%) of the total refuse bill added if the bill is not timely paid within twenty-five (25) days after the billing date.

Section II:

A charge of \$1.00 per car tire and \$5.00 per truck tire shall be charged when the Municipality picks up any tire or tires while providing trash and garbage collection service at any location.

Section III:

As a result of this adjustment for March, April and May, 1993, Council will not impose any additional increases for refuse rates until the January 1995 billing or later, depending on the financial conditions of the fund.

Section IV:

This Ordinance shall revoke and rescind all Ordinances, parts of Ordinances, and Resolutions and parts of Resolutions that are in conflict herewith and shall be enforced from and after the earliest period allowed by law.
