Ordinance No. 1992-08

Passed May 5, 19 92

AN ORDINANCE ESTABLISHING ADDITIONAL TRAFFIC CONTROL BY PROVIDING A ONE WAY STREET IN GOLDEN GATE PARK AND DECLARING AN EMERGENCY.

WHEREAS, it has recently come to the attention of the Council of the Municipality of Brookville, Ohio that there has been increased traffic at Golden Gate Park, especially during the summer months; and

WHEREAS, due to the fact of having increased traffic, it is deemed necessary to preserve the welfare, health, and safety of the citizens of Brookville, Ohio, to provide for one way direction on a portion of the road through Golden Gate Park and to declare an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

## SECTION I:

That portion of the roadway extending from the west gate through the park out to the east gate of Golden Gate Park (both of which exit onto Upper Lewisburg Salem Road) shall be made one way beginning at the three way intersection on the said same road and continuing until the road ends at Upper Lewisburg Salem Road at the east gate, the said direction being such that all traffic shall be directed from the three way intersection out onto Upper Lewisburg Salem Road at the east exit.

## SECTION II:

This Ordinance shall revoke and rescind all Ordinances, parts of Ordinances, and Resolutions and parts of Resolutions that are in conflict herewith

## SECTION III:

This Ordinance is hereby declared to be an Emergency Ordinance for the immediate preservation of the public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio and this Ordinance shall take effect and be in full force and effect from and after its passage by a two-thirds majority of council as provided for in the chart of Municipality of Brookville, Ohio.
