AN ORDINANCE AMENDING THE CODE OF ORDINANCES TITLE 5, SECTION 50.30, PARAGRAPH A - AN ORDINANCE FIXING THE RATES AND CHARGES TO ALL WATER CONSUMERS AND SECTION 50.09 FIXING THE TAPPING PERMIT FEES IN THE MUNICIPALITY OF BROOKVILLE, OHIO.

NOW, THEREFORE, BE IT ORDAINTED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

There shall be a minimum charge in case of water billed quarterly for the first 1,000 cubic feet consumed per quarter, which minimum charge is to cover investment, overhead expense and the cost of being ready to serve with water. These minimum charges will be payable quarterly as due, at the following rates for the various sized meters.

MINIMUM CHARGES 1,000 CUBIC FEET OR LESS PER QUARTER

1/2 or 5/8 inch meters	\$ 34.50
3/4 inch meter	38.75
1 inch meter	50.75
1½ inch meter	72.80
2 inch meter	109.50
3 inch meter	217.60
4 inch meter	328.05
6 inch meter	565.20

The following shall be additional charges per thousand cubic feet per quarter for the:

Next 9,000 cubic feet	\$ 15.00
Next 90,000 cubic feet	14.25
Next 400,000 cubic feet	13.55
Over 500,000 cubic feet	12.90

These rates shall start and be in effect on the October, 1992 billing for the water consumed during the previous quarter of June through August.

SECTION II:

In order to have water service installed in any premise a tapping permit must be secured in the amount of \$350.00 at the Brookville Water Department Offices, setting forth the Municipal lot and street number. Then a permit must be taken out and a service signed for at the office of the Dayton Division of Building Inspection of the Department of Service and Building by a duly licensed plumber. The tapping permit fee of \$350.00 will be in effect as of January 1, 1993.

SECTION III:

If any sentence, clause, section or part of this Ordinance is found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall affect only such clause, sentence, section or part of this Ordinance and shall not affect or impair any of the remaining provisions, sentences, clauses, sections or other parts of this Ordinance. It is hereby declared to be the intention of the Council of the Municipality of Brookville that this Ordinance would have been adopted has such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.
