## AN ORDINANCE CHANGING THE SPEED LIMIT ON BROOKVILLE-JOHNSVILLE ROAD AND DECLARING IT AN EMERGENCY.

WHEREAS, it has come to the attention of the council of the Municipality of Brookville, Ohio that due to the present borders of the Municipality of Brookville, Ohio confusion results due to the present speed limit of 35 miles per hour on that portion of Brookville-Johnsville Road located within the Municipal Corporate limits; and

WHEREAS, the Council of the Municipality of Brookville, Ohio, has requested and received from a traffic engineer, a study and opinion indicating that it is advisable to raise the speed limit on that portion of Brookville-Johnsville Road located within the Municipal Corporate limits to that speed limit currently posted on that portion of Brookville-Johnsville Road outside of the said Corporate limits; and

WHEREAS, it is deemed necessary for the preservation of the health, welfare and safety of the citizens of the Municipality of Brookville, Ohio, to pass this Ordinance in the form of an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

### SECTION I:

The speed limit of 35 miles per hour shall be changed and raised to 45 miles per hour on the portion of Brookville-Johnsville Road located within the Municipal Corporate limits of the Municipality of Brookville, Ohio.

### SECTION II:

This Ordinance is hereby declared to be an emergency ordinance for the immediate preservation of the public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio and this Ordinance shall take effect and be in full force and effect from and after its passage by a two-thirds majority of council as provided for in the chart of Municipality of Brookville, Ohio.
