Ordinance No. 1992-13

Passed September 15, 19 92

AN ORDINANCE PROHIBITING THE PARKING OF VEHICLES ONE TON OR OVER IN SIZE FROM PARKING IN ANY MUNICIPAL OWNED PUBLIC PARKING LOT AND DECLARING IT AN EMERGENCY.

WHEREAS, the Municipality of Brookville, Ohio has a Municipal owned public parking lot; and

WHEREAS, it has come to the attention of the council of the Municipality of Brookville, Ohio, that certain vehicles, specifically trucks in the size of one ton or higher, park in the said parking lot for long periods of time; and

WHEREAS, it is deemed to be a nuisance to the businesses currently using the Municipal parking lot; and

WHEREAS, this is for the immediate preservation of the public health, safety and welfare of the citizens of Brookville, Ohio, that this measure be declared an emergency measure.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

## SECTION I:

It shall be unlawful for any person or persons to cause any vehicle, one ton or greater in size, to stand upon any Municipal owned public parking lot for any purpose.

## SECTION II:

It is expressly understood that all Municipally owned vehicles one ton or greater in size are exempted from the provisions of Section I under this Ordinance and that they may be permitted to park in any Municipally owned parking lot without incurring any violation of law.

## SECTION III:

A violation of Section I of this Ordinance shall be considered to be a minor degree misdemeanor.

## SECTION IV:

This Ordinance is hereby declared to be an emergency ordinance for the immediate preservation of the public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio and this Ordinance shall take effect and be in full force and effect from and after its passage by a two-
