Ordinance No. 1992-15

Passed October 20, 1992

AN ORDINANCE AMENDING SECTION 34.04 OF THE MUNICIPAL CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO RELATING TO THE AMOUNT OF MONEY TO BE PLACED IN THE BUYER CAPITAL IMPROVEMENTS FUND AND DECLARING IT AN EMERGENCY.

WHEREAS, it has been deemed necessary for the health, safety and welfare of the citizens of the Municipality of Brookville, Ohio, to create a Fire Capital Improvements Fund to provide for replacement and newer and more efficient fire equipment; and

WHEREAS, it is further deemed to be necessary to occasionally adjust the amounts of monies received by the Municipality in order to adequately provide for the various equipment needs of the Fire Department of Brookville, Ohio.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

SECTION I:

Section 34.04 (B) shall be amended to read as follows: The Council of the Municipality of Brookville, Ohio, shall set and establish the amount of the monies that are received by the Municipality of Brookville, Ohio, from payments made pursuant to Buyer Protection Contracts which shall then be placed in the Fire Capital Improvements Fund (fire equipment).

SECTION II:

This Ordinance is hereby declared to be an emergency ordinance for the immediate preservation of the public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio and this Ordinance shall take effect and be in full force and effect from and after its passage by a two-thirds majority of council as provided for in the chart of Municipality of Brookville, Ohio.


