Ordinance No. 1991-04

Passed April 2, 1991

AN ORDINANCE AMENDING THE BUILDING CODE OF THE MUNICIPALITY OF BROOKVILLE, MODIFYING THE DWELLING CODE AND DECLARING IT AN EMERGENCY.

WHEREAS, it is deemed to be in the best interest of the citizens of the Municipality of Brookville to update its dwelling code to reflect recent amendments thereto.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, STATE OF OHIO:

## SECTION I:

There is hereby adopted, for the purpose of establishing rules and regulations for the erection, construction, enlargement, alteration, repair, improvement, removal, conversion, demolition, equipment, use, occupancy or maintenance of one, two, or three family dwelling houses which are not constructed of industrialized units and their accessory structures, that certain code known as the One and Two Family Dwelling Code 1989 Edition, published jointly by the Building Officials and Code Administrators International, Inc.; International Conference of Building Officials; and Southern Building Code Congress International.

## SECTION II:

Copies of Codes and amendments thereto, adopted in this Chapter are on file with the Building Inspection Department for inspection by the public.

## SECTION III:

This Ordinance shall rescind any and all ordinances or resolutions or any parts thereof that maybe in conflict herewith.

## SECTION IV:

This Ordinance is hereby declared to be an emergency ordinance for the reason that said code needs to be filed with the Montgomery County Building Department and must be enforced and administered according to law; wherefore this ordinance shall take effect and be in force immediately upon its passage.
