AN ORDINANCE ZONING CERTAIN LOTS OF THE REVISED CONSECUTIVE NUMBER OF LOTS OF THE MUNICIPALITY OF BROOKVILLE, OHIO TO A NEW CLASSIFICATION OF "HS".

WHEREAS, the Municipality of Brookville, Ohio, recently annexed certain territory along northwest side of Interstate 70 and southwest of Upper Lewisburg-Salem Road of 16.60 acres to the Municipality of Brookville; and

WHEREAS, it has been deemed necessary and proper to provide zoning for this newly annexed territory.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO:

SECTION I:

The classification of the real estate recently annexed to the Municipality of Brookville, Ohio along northwest side of Interstate 70 and southwest of Upper Lewisburg-Salem Road consisting of 16.60 acres is hereby zoned to the classification of "HS" pursuant to the Zoning Ordinances of the Municipality of Brookville, Ohio.

SECTION II:

This Ordinance shall revoke and rescind all ordinances, parts of ordinances and resolutions and parts of resolutions that are in conflict herewith and shall be in force from and after the earliest period allowed by law.

OHIO





