AN ORDINANCE AMENDING THE CODE OF ORDINANCES TITLE 5, SECTION 51.20, PAR. (D)(1) AND SECTION 51.21, PAR. (A) - AN ORDINANCE FIXING THE RATES AND CHARGES TO ALL SANITARY SEWER CUSTOMERS IN THE MUNICIPALITY OF BROOKVILLE, OHIO.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, THAT:

## SECTION I:

Section 51.20 (D)(1) of the Code of Ordinances shall be amended to read as follows:

The following shall be the quarterly rates charged by the Municipality for services rendered by its sanitary sewage system to its inhabitants and others based on water consumption. The rate schedule shall apply effective on the January 1992 billing for sewer usage as follows on domestic strength wastewater:

- First: Minimum charge for 1000 cubic feet or less per quarter - \$17.50
- Second: Charge for each 100 cubic feet or any part thereof, in excess of 1000 cubic feet, but less than 10,000 cubic feet - \$1.75
- Third: Charge for each 100 cubic feet or any part thereof, in excess of 10,000 cubic feet - \$1.35
- Fourth: There will be a 25% additional fee for consumers living outside of the Municipal Corporation limits.

## SECTION II:

Section 51.21 (A) of the Code of Ordinances shall be amended to read as follows:

Before any person connects to or discharges sewerage into the sanitary sewer system or extends the use of the sanitary sewer system on his premises to additional dwelling, commercial, manufacturing, or other units, he shall pay to the municipality as the permit fee for connecting to and discharging sewage into the sanitary sewer system a fee in the amounts shown below.

(A) For all connections to the sanitary sewer system, the fee shall be in the amount for the respective uses shown below, but in no case less than \$350.00.

<u>Residential</u>	<u>Fee</u>
Single-family residence	\$350.00
Two-family residence	500.00
Multi-family apartments	350.00 plus \$150.00 for each additional unit
<u>Non-Residential</u>	
Commercial, Industrial, Institutional, Schools, Governmental	\$350.00 plus \$.20 per sq.ft.






