Ordinance No. 1990-01

Passed April 17, 1990

AN ORDINANCE AMENDING SECTION 76.08 OF THE CODE OF ORDINANCE OF THE MUNICIPALITY OF BROOKVILLE BY ADDITION OF THREE (3) HOURS RESTRICTED PARKING AREA PLUS AMENDING THE PENALTY CHARGE FOR PARKING VIOLATIONS AND DECLARING IT AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE MUNICIPALITY OF BROOKVILLE, OHIO, that:

SECTION I:

The addition of vehicle parking restrictions on the north side of Market Street for the first four parking spaces between Columbia Street and Jefferson Street starting at Columbia Street and proceeding east to three (3) continuous hours between the hours of 8:00 A.M. and 6:00 P.M. The three (3) hours restricted period shall not apply to Sundays and public holidays. Signs shall be erected indicating the three (3) hour parking limitation.

SECTION II:

Section 76.08 (D) of the Code of Ordinance shall be amended to read, "Whoever violates restricted parking limitation provided herein shall be subject to a minor misdemeanor citation and penalty".

(1) If the payment of the penalty is made within twenty-four (24) hours after it is issued, the penalty shall be five dollars (\$5.00).

(2) If the payment of the penalty is made between twenty-four (24) hours and seventy-two (72) hours after it is issued, the penalty shall be ten dollars (\$10.00).

(3) If the payment of the penalty is not made within seventy-two (72) hours after it is issued, the penalty shall be a fine of not more than one hundred dollars (\$100.00) for the first conviction and a fine of not less than ten dollars (\$10.00) nor more than one hundred dollars (\$100.00) for the second and subsequent convictions.

SECTION III:

Section 76.08 (E) of the Code of Ordinance shall be amended to read, "Payment of any penalty regarding parking restrictions shall be made in cash. Payment shall be made at the Brookville Communication (Dispatch) Office in person or by mail to the Brookville Municipal Office".

SECTION IV:

This Ordinance is hereby declared to be an emergency ordinance to provide orderly regulation of the parking of vehicles in the central business district of the Municipality to preserve the public peace and welfare of the citizens of the Municipality of Brookville, Ohio.
