AN ORDINANCE LEVYING THE MUNICIPAL FIVE DOLLARS (\$5.00) MOTOR VEHICLE LICENSE TAX AS AUTHORIZED BY AM. SUB. H.B. 419.

## LEVY OF ANNUAL TAX ON MOTOR VEHICLES

There is hereby levied an annual license tax upon the operation of motor vehicles on the public roads or highways pursuant to Section 4504.172, Ohio Revised Code, for the purposes of paying the costs and expenses of enforcing and administering the tax provided for in this section; and to provide additional revenue for the purposes set forth in Section 4504.06, Ohio Revised Code; and to supplement revenue already available for such purposes.

Such tax shall be at the rate of Five Dollars (\$5.00) per motor vehicle on each and every motor vehicle the district of registration of which, as defined in Section 4503.10 of the Ohio Revised Code, is in the Municipality of Brookville, Ohio.

As used in this ordinance, the term "motor vehicle" means any and all vehicles included within the definition of motor vehicle in Section 4501.01 and 4505.01 of the Ohio Revised Code.

## DURATION OF THE TAX

The tax imposed by this ordinance shall apply to and be in effect for the registration year commencing January 1, 1991 and shall continue in effect and application during each registration year thereafter.

## PAYMENT OF THE TAX


The tax imposed by this ordinance shall be paid to the Registrar of Motor Vehicles of the State of Ohio or to a Deputy Registrar at the time application for registration of a motor vehicle is made as provided in Section 4503.10 of the Ohio Revised Code.

## DISPOSITION OF PROCEEDS

All moneys derived from the tax hereinbefore levied shall be used by the Municipality of Brookville, Ohio for the purposes specified in this ordinance.
