Ordinance No. 1990-06

Passed June 19, 19 90

AN ORDINANCE TO PROVIDE ADDITIONAL NO PARKING ZONES ON STREETS WITHIN THE MUNICIPALITY OF BROOKVILLE, OHIO, SPECIFICALLY ON ARLINGTON ROAD FROM RONA PARKWAY SOUTH TO THE NORTH SIDE OF ARLINGTON ARMS APARTMENTS ON BOTH SIDES OF THE ROADWAY AND DECLARING IT AN EMERGENCY.

WHEREAS, the traffic patterns have been increased on Arlington Road; and

WHEREAS, as a result of the necessity to provide for an even flow of the traffic patterns, it is necessary to declare certain areas as being no parking zones along those roadways; and

WHEREAS, it is now deemed necessary for the safety and welfare of the Municipality of Brookville, Ohio, and for its citizens, for the Council of the Municipality of Brookville, Ohio, to designate a certain area of Arlington Road as being no parking zones.

NOW, THEREFORE, be it ordained by the Council of the Municipality of Brookville, Ohio, that:

SECTION I.

Arlington Road from Rona Parkway south to the north side of Arlington Arms Apartments on both sides of the roadway shall hereby be declared no parking zones and appropriate signs and markings shall be posted identifying these areas as being no parking zones.

SECTION II.

This Ordinance is hereby declared to be an emergency ordinance in order to preserve the public peace, health, safety and welfare of the citizens of the Municipality of Brookville, Ohio. This Ordinance shall take effect and be in full force from and after the date has been passed according to the charter of the Municipality of Brookville, Ohio.
